The Superintendent relayed that this is an opportunity that can only be used for switches, hubs and wiring. The approved amount is no less than \$28,000 and could be closer to \$40,000. The Board needs to approve 25% of the capital funds, which will probably be \$9,000 maximum, the exact figure is unknown at this point in time. The Superintendent will request the use of the capital improvement funds that the auditor suggested be paid down. Some of those funds were used last year to improve the infrastructure at Granite Street School. There will be no budget funds used.
